REGISTRATION

Registrations are not binding until payment has been made in full.

Payment of Registration

The payment of the registration is either by credit card or bank deposit at the time of registration.

A registration is considered complete when full payment is received by the Conference Organiser.

The Australian goods and services tax (GST) at 10% is applicable to all goods and services offered by the Conference. All registration fees listed include GST.

Cancellation of Registration and Part Registration

Registrations can be cancelled and a full refund made up to 5 working days prior to the start of the conference, i.e. by close of business Monday 16 October 2023.

Registrations cancelled within 5 working days will attract a \$100 administration fee, regardless of circumstances.

Registrations within 24 hours of the conference do not attract a refund.
